Motion: G. Engle, Second: B. Ellis to explore the possibility of paying Curtis Jones to come to St. Matthew's on the 2nd and 4th Sunday's of January – May. Motion passed unanimously. Lorrie will talk with Curtis about his willingness to take on two more Sunday's.

M. Hood reported that each church's assessment to the Diocese would be increasing from 10% to 10.25%.

Old Business:

New Business:

The Stewardship Campaign ended with 23 pledges + 3 more promised for a total of \$55,670. Motion: B. Ellis, Second: M. Hood to approve the 2016 budget except for the changes to Lorrie's salary /stipend (if needed) and the Diocesan assessment increase of 10.25%. Motion passed unanimously.

Ellis to reimburse Lorrie the cost of the items she purchased for CJCohn (\$175) with Dollars for Outreach funds and the balance of those available funds are to go to Arkansas Food Bank Network if it's at least \$100. Motion passed unanimously.
