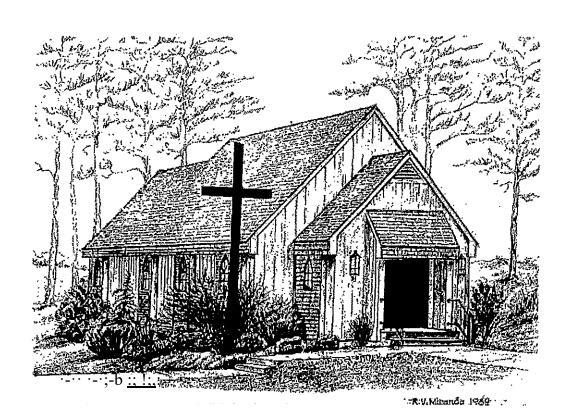
Jay will appoint the Senior Warden in February. Vestry will elect the Junior Warden, treasurer and secretary at the February vestry meeting.

hope that it will continue to be serviced by our members for as long as it is needed.

It was fun this year doing the Blessing of the Animals online with Jay. We had some women from New York, and it was all a hoot. They will look us up if they ever come to

Arkansas! I did send them certificates for their animals.

I want to thank those of you who made the trek up to the Village to bring me goodies,

food, a stuffed animal, and most of all for your calls, cards, etc. after my accident this

spring. They all really meant a lot to me!

I genuinely love serving at St. Matthew's and being with all of you when we can be. I am

also thrilled at the prospect of being able to work with Jay now that he will truly be our

Vicar!

### **2020 SENIOR WARDEN'S REPORT**

This past year we faced many challenges as we have had to learn different ways to continue to be the church during a pandemic. You could say we spent most of the year learning how to be the church without being in the church. In spite of COVID-19, St. Matthew's community has shown that they are a caring group of people working together to answer God's call.

St. Matthew's Vestry worked extremely hard in 2020. While continuing to monitor the health and well-being of all in our church remotely, our finances and the condition of the church building and grounds, there has been another area of focus for the Vestry-trying to find ways to continue our work as stewards of our faith community in challenging times. Two members of the Vestry have completed their terms and will be going off this year, Fanny Neely and myself. Selena Ellis and Ellen Gregan have graciously agreed to have their names submitted to fill the two vacancies.

St. Matthew's Vestry renamed the Blessings Cabinet "James' Pantry" in September after longtime member, James Mattocks, who passed away September 5, 2020. The church has been able to continue to stock the pantry weekly in spite of the pandemic and have had two successful "perishable food" giveaways because of generous donations to the pantry. In December, we were notified by someone who wishes to remain anonymous that they would like to donate \$1000.00 to the pantry if we could match those funds. As of January 2s'h, that amount has been matched, netting the pantry \$2200.00!

We had the Blessing of the Animals via Zoom and it was different, but I think everyone who attended with their furry friends enjoyed it.

Both of the church properties, the RB House and the vicarage, are currently rented and have been for all of 2020 by two faithful tenants. This is a blessing, not to mention a reliable source of income.

We have all discussed how the pandemic has disrupted our lives and how we are missing in-person worship. In this new normal, when we cannot gather as we have in the past and we are coming together virtually, I think we are learning new things about one another that we might not have learned if we were gathering in person. We are fellowshipping!

I have been honored to serve as Senior Warden the past two years and want to thank you for all the help you have given me. We have been blessed to have Rev. Jay Bruno as our Supply Priest and Rev. ### **2020 ALTAR GUILD REPORT**

Every church service begins and ends with the work of the Altar Guild. Each week members assist the clergy and *serve* the church by preparing the sacraments and maintaining all supplies necessary for worship services and then clean up afterwards.

The Altar Guild consists of teams of 2-3 members who rotate duties on a monthly basis usually three or four times a year. Members are assigned to a team each month and when it is our assigned month, we are here for special services during that month as well as worship on Sunday. We also meet two times a year for cleaning and polishing silver/brass to prepare for Christmas and Easter.

## Summary of 2020 Stewardship and 2021 Budget

## 2020

- 1. There were 21 pledges for 2020; \$53,080 was pledged; the average pledge was \$2528.
- 2. \$50,064 (>94%) of pledged income was contributed.
- 3. Plate offerings were less (\$4143) than budgeted (\$6000) due to pandemic
- 4. Overall income was about \$5500 more than budgeted.
- 5. Expenses were approximately \$31,600 less than budgeted; the bulk of the savings were in personnel. We had budgeted for a *Yi* time priest beginning in July of 2020.

## 2021

- 1. There are 18 pledges with a total of \$44,880 pledged; average pledge is \$2493.
- 2. Budget includes *Yi* time vicar beginning in February.
- 3. Anticipate approximately \$9300 deficit for this year, but there is a sufficient cushion to cover the deficit.
